THIS SUPPLEMENTARY MEMORANDUM OF UNDERSTANDING is made on ... August

BETWEEN

UNIVERSITI KEBANGSAAN MALAYSIA, a public institution of higher learning established under the Universities and University Colleges Act 1971 [Act 30], and having its address at 43600 UKM Bangi, Selangor Darul Ehsan, MALAYSIA (hereinafter referred to as "**UKM**") of the one part;

AND

CHIANG MAI UNIVERSITY, a public institution of higher learning in Thailand and having its address at 239, Huay Kaew Road, Muang District, Chiang Mai, 50200, THAILAND (hereinafter referred to as "**CMU**") of the other part.

UKM and **CMU** shall hereinafter be referred to singularly as "the Party" and jointly as "the Parties".

WHEREAS:

- A. The Parties have entered into a Memorandum of Understanding dated 24th July 2017 (hereinafter referred to as "the Principal MoU") for the purpose of collaborating, promoting and developing teaching and research between **UKM** and **CMU**.
- B. Pursuant to Article 6 of the Principal MoU, the Parties may amend any term of the Principal MoU by the execution of a Supplementary Memorandum of Understanding.
- C. The Parties have agreed to sign this Supplementary Memorandum of Understanding (hereinafter referred to as "this Supplementary MoU") upon the terms and conditions hereinafter contained.

NOW THE PARTIES HEREBY AGREE AS FOLLOWS:

ARTICLE 1 SUPPLEMENTARY

1.1 The Parties hereby agreed that this Supplementary MoU shall be supplementary to and be read and construed as an integral part of the Principal MoU.

- 1.2 Save and subject to the provisions and variations contained in this Supplementary MoU, all the provisions of the Principal MoU shall remain the same and be in full force and effect as between the Parties.
- 1.3 In the event of any conflict or inconsistency between the provisions of the Principal MoU and this Supplementary MoU, the provisions of this Supplementary MoU shall prevail to extent of such conflict or inconsistency.

ARTICLE 2 INTERPRETATION

In this Supplementary MoU unless the context otherwise requires and save as specifically defined herein, all words and expressions defined in the Principal MoU shall have the same meaning when used or referred to in this Supplementary MoU.

ARTICLE 3 COMMENCEMENT DATE

This Memorandum of Understanding shall come into force on the date of signing and shall remain in force for a period of three (3) years subject to review and modification as mutually agreed upon.

ARTICLE 4 AMENDMENT OF APPENDIX A OF THE PRINCIPAL MOU

4.1 The Principal MoU is amended by inserting new activities namely activity 6, 7, 8 and 9 as follows:

"Based upon principles of international educational exchange (mutual respect and benefit, co-operation, collaboration, and understanding), Universiti Kebangsaan Malaysia and Chiang Mai University, agree to explore the following collaborative activities:

- 1. Organisation of joint academic activities, such as : courses, conferences, seminars, symposia or lectures;
- Organisation of joint outreach programs for potential students in partner country;
- 3. Exchange of students and teaching personnel;
- 4. Placement of students and teaching personnel;
- 5. Participation in research by faculty members of partner institution;

- 6. **CMU** agrees to act as a training ground for **UKM**'s Faculty of Health Sciences students;
- 7. **UKM** agrees to act as a training ground for **CMU**'s Faculty of Associated Medical Sciences students;
- 8. **CMU** agrees to provide occasional supervision to **UKM**'s Faculty of Health Sciences students during the placement and/or industrial training at **CMU**;
- UKM agrees to provide provide occasional supervision to CMU's Faculty of Associated Medical Sciences students' during the placement and/or industrial training at UKM; and
- 10. Exchange of publications and other materials of common interest."
